5. Many Senators discuss Section 7 subsection D of the bill.
6. Senator Corpus motions to remove subsection D from the bill and vote by roll call. Failed.
7. Motion to remove the amended Subsection D. Passed by roll call vote.
8. Senator Villarreal motions to remove and "and a member of the Supreme Court." unanimous consent. Passed.
9. Senator Corpus motions to table the bill indefinitely. Failed.
10. Senator Tilley motions to vote on S2017-B5 by roll call vote.
