V. New Business

- a. F2019 R1 Fair Disciplinary Action for Drug Policy Violations
 - i. Senator Daniel: Where are the statistics on other drugs (opioids etc)? How can we make sure that students aren't in possession of more harmful drugs such as cocaine?
 - Devon: we are trying to make sure first-time offenses give
 the opportunity to make the right decision. Want
 opportunity for rehabilitation and education. We can get
 statistics on opioids/schedule 1 drugs and follow up. Want to
 show alcohol that alcohol can be as dangerous as other
 drugs.
 - ii. Senator Asia: could we consider making education mandatory?
 Devon: we can fix and look at wording. It is our intention to send to rehabilitation services rather than penalty
 - iii. Senator Jennifer: gave statistics why drugs are bad, state we already make exception for alcohol, why are we providing statistics on alcohol?

Devon: alcohol related penalties are less than other drugs. Want to make sure alcohol is put on the same level as other drugs.

iv. Senator Subecha: catering toward alcohol, should add more awareness to other drugs.



Senator Devon: want to make sure first-time drug offenders have a second change on campus. Intention is to rehabilitate first time offenders.

v. Senator Victory: Talked about leaving racial part, would you consider taking out racial aspect?

Devon: intention was not to blame racial minorities. Currently dean of students has a wide range of penalties, want to make sure there's no bias in penalties. Language is not intended to target.

vi. Senator Victory: what will be penalty other than what is given by criminal justice system?

Devon: suggestion is that they're sent to rehabilitation services so they can then be a part of the unt community once again.

vii. Senator Asia: Mention alcohol and exceptions, everyone else why not talk about all other drugs and claim why don't we put on the same level as alcohol and marijuana.

Devon: currently if you're penalized for marijuana and alcohol they can still apply heavy penalties for marijuana. It's our belief that response should be educational. Want to decrease penalties for first time offenses. Our job as a university is to educate.

viii. Senator Keaton: why aren't the statistics about the positive on rehabilitation rather than negative effects? Why trying to demonize alcohol when the goal is to make none of them demonized?

Devon: statistics were meant to inform; goal is to make sure students on campus have educational responses to that. If statistics are of concern, we can reassess. Impossible to add every drug.



ix. Senator Enzo: in the statistics, you have men and women, but later break it down to demographic, would you be open to making amendment to appropriately reflect?

Senator Chris: I see that you're trying to change university policy How do you separate repeat offenders who haven't been caught and those who are first time drug offenders?

Senator Daniel: have you considered change in campus culture? A lot of drugs have drug related violence, have you thought of change of campus climate?
