- b. S2020 R1 Grief Absence Policy Resolution
  - i. No new changes
  - ii. Discussion
    - Alyissa (A): Does this legislation apply to out of state students as well
    - 2. Marisela (M): Yep, as long as students apply for a grief excused absence
    - 3. Alyissa: I have personal experience with an applicable situation, and it took four months of traveling back and forth with home to deal with a death in my family
    - 4. Daniel: Most grief related absences are not excused in blended families because they do not share the same last name.
    - 5. Marisella: I will be considering a fix in the future, but I would be fine with different types of verification
    - 6. Daniel: On the further resolved, can we add an amendment so that this policy applies regardless of surname or regardless of name in funeral programs
      - i. Amended further resolved so that it says
      - ii. ... regardless of surname or student name in program



- 7. Alyissa: I would like to make an amendment this Further resolved: that it applies to students grieving regardless of relationship
  - a. some relationships are personal, like if they were foster parents
  - b. Deana: The resolution does contain that wording "loved one" to address this point
  - c. Daniel: We could still add an amendment to emphasize this point. We should add another line
- 8. Amendment Approved by unanimous consent
- 9. Victory:I do not agree with how we have to show prove of death before this policy applies. It might be hard on the students. How does this policy work currently
- 10. Alyissa: I needed to provide verification that my family member was dying in advance. A family member could send in proof, but it felt unfair
- 11. Ryene: Can we let students bring up evidence both before and after the grieving period. There are issues with committing with one method or the other.
- 12. Daniel: What if a family member dies suddenly. It seems unfair to provide proof before the death
- 13. Devon: Professors still have the right to remove students from class after a certain number of students

14. Alison: The Deans of Students already contacts the professors so that the student themselves to not have to dig up the proof. Professors may be skeptical to a fault.
